



TSA Instruction for SkyEagle Aviation Academy's

ATP and ATP-CTP students

All Non-US Citizens are required by law to register with the United States Transportation Security Administration prior to commencing flight training in the U.S. This is an online process. (Please read all instructions before registering.)

TSA clearance required for: ATP-CTP course / ATP training

NOTE: if you want to do ATP-CTP and then ATP (non-type) you must create TWO applications!

NOTE: You cannot start your flight training unless TSA issues final approval!

Stage 1: Click on the link <u>https://www.fts.tsa.dhs.gov/</u>, click on "Register Option" -> "Candidate Portal" (right upper corner). Once all the personal information has been filled out and submitted you will receive an email with a user ID and Password. (See Helpful Hints below).

Stage 2: Go back to the link above and type in user ID and Password and proceed with the AFSP online application process.

Stage 3: Click on "Create Training request" and follow all steps, don't forget to "Save record" your application after each page.

You are creating a draft training event request. TSA has defined a flight training event as instruction received from a flight school in an aircraft or aircraft simulator that a candidate could use toward a new airman certificate, i.e., for an initial rating, instrument rating, multi-engine rating, type rating, or recurrent training, whether on fixed-wing or rotary aircraft.

Each training event carries a fee of \$130. You will not be able to pay the fee until a flight training provider accepts your draft training event request. You cannot combine training event requests.

Stage 4: Upon submission of the completed training request forms, the AFSP confirms the validity of the training request with the flight training provider identified by the candidate.

Stage 5: Upon acknowledgement of the candidate's request for flight training by the flight training provider, the candidate will be notified by AFSP and directed to pay the \$130 USD processing fee.

The flight training candidate must complete a training request for each course or instance of training he/she wishes to attend, even if the training is with the same flight training provider.

Stage 7: If the preliminary decision is favorable, the candidate will be provided with instructions on how to submit fingerprints. An approval email will be sent to both candidate and training provider.

All students may commence training after fingerprints have sent off by traceable means to the TSA by SkyEagle Aviation Academy. Fingerprints must be submitted, and TSA clearance must be received before you can begin flight training (including FTD and FFS simulator devices).

For ATP Training (non-type):

 - **Course ID:** 005 for ATP
 - Class name: Multi-engine ATP
 - Aircraft type: BE76
 - Estimated start date: actual date when you arrive and ready to start training
 - Estimated end date: we advise to use 365 days since Start Date (maximum allowable term).
